Overview

How can we maximise the support available to low income households in the austerity era? A one-day course run in partnership with Greater Manchester Poverty Action (GMPA).

This course will explore how to access and identify support for people on low incomes in the context of social security reforms and cuts. This course is for VCSE organisations who work with people experiencing poverty and who wish to understand how to maximise support for their service users and public sector professionals involved in service design and delivery. It will also be of interest to researchers seeking to understand the current social security landscape.

Background

Since 2010 the government have made a raft of changes to the social security system through welfare cuts and reforms. At the same time, local authorities have faced budgetary pressures resulting in cuts to support and services traditionally provided at a local level. A new grassroots response, usually led by the VCSE sector, has emerged through things like food banks and other initiatives aimed at responding to the needs of people facing hardship.

The aim of this course is to equip attendees with the knowledge they need to signpost people experiencing poverty to avenues of support and to think about how policy and service design and deliver can better respond to an ever-changing social security landscape.

What will this course cover?

Concentrating on support for working age adults, this course will assess the current state of support for low income households through the social security and wider support system. It will:

- Review cuts and reforms to working age benefits since 2010

- Look at benefit take up and opportunities for maximising support through the social security system for low income households
- Assess the impact of financial pressures on local authorities on local service delivery and support
- Review the extent and nature of VCSE sector support and delivery and consider how this has developed and evolved since 2010
- Look at case study examples of effective joined up support at a local level
- Discuss what learning from the course means in respect of your work.

He has also represented the UK as a non-governmental expert on poverty internationally, been a keynote speaker at several academic conferences and represented both Oxfam and Save the Children in national, regional and local broadcast media.
